#### **CLUB AGMS**

The Annual General Meeting (AGM) season is always a busy time for our Clubs, and this year was no exception. Our Communications and Operations lead, Mike Plant, was invited to a few of our affiliated clubs during this AGM season, leaving a positive mark on various sportfishing clubs and their members.

Mike Plant, joined by NZSFC vice president Andrew Johnson were invited to speak at the Mangawhai Sportfishing Club AGM. Attendees were encouraged to have them address their concerns and answer questions regarding the proposed Hauraki Gulf Marine Park with concerns bottom trawling would intensify in Bream Bay. Andrew and Mike provided valuable insights, and have encouraged Mangawhai to have their voice heard through attending zone 2 meetings where affiliated clubs are sharing similar concerns.

Following his visit to Mangawhai, Mike Plant continued his AGM journey to the Warkworth Sportfishing Club. There, he engaged with members, discussing the importance of responsible fishing practices and the significance of the proposed marine park in preserving their beloved fishing grounds. His presence at the AGM served as a reminder that the angling community plays a vital role in protecting New Zealand's coastal waters.

The final stop on Mike Plant's AGM tour was the Hauraki Gulf Sport Fishing Club AGM. This event was particularly significant, as it was an AGM prize giving and fishing comp all in one. Mike addressed the club members, sharing insights on the marine park's potential detrimental effects to both fish stocks and recreational anglers. In addition Mike had the privilege of handing out awards on behalf of the New Zealand Sportfishing Council at these AGMs.

## HAURAKI GULF MARINE PARK

Notable developments in the Hauraki Gulf Marine Park include:

- 1. Approval of Fisheries Plan: The Hauraki Gulf Marine Park Fisheries Plan has been approved.
- 2. Marine Protection Bill: The Hauraki Gulf/Tikapa Moana Marine Protection Bill, supporting 19 new MPAs, has been introduced into Parliament and referred to the Environment Select Committee. Submissions will likely be called for around the end of 2023.

- 3. Trawl Zone Consultation: Consultation is ongoing for trawl zones, with submissions due by November 6th. This could result in displacement of fishing effort into East Northland, Coromandel, and Bay of Plenty.
- 4. Unresolved Issues: The plan does not adequately address concerns related to overfishing, depletion, and the use of bulk harvesting and destructive bottom-contact fishing methods.

# NZMRF UPDATE FROM JEFF ROMERIL - CHAIRMAN

In August, Jeff Romeril issued an email to all Clubs from the NZMRF, he will also report to the AGM the following:

The New Zealand Marine Research Foundation plays a vital role in supporting marine research for the benefit of recreational fishers. Established by the NZSFC in the early '90s, it officially began its work in 1999. Initially funded at 50 cents per member per year, contributions have since grown to \$2 for adults and \$1 for juniors.

The foundation, led by trustees with strong ties to NZSFC, has undertaken significant projects. Notable achievements include long-term satellite tagging of marlin, fish welfare research that influenced government decisions on animal welfare, and the creation of a valuable recreational fishing reference document. Currently, they're considering research on "mushy fish" (snapper) and assisting with artificial reef creation.

NZSFC clubs' donations are crucial for the foundation's operations. This funding largely determines the effectiveness of NZMRF. The foundation reports annually to the NZSFC AGM, and these donations are a substantial contribution. NZSFC's support through its Administration Officer, Helen Pastor, is also greatly appreciated.

Despite challenges, including the impact of COVID-19, NZMRF has built a strong financial reserve and completed various projects. They're now focusing on studying mushy snapper and considering creating artificial reefs from aquaculture shell waste.

Regarding trustees, there have been changes, with new additions of Rick Pollock and Pete Saul following the resignation of John Rae and Dr Peter Davies. There are plans for further expansion in the future.

The NZMRF is reliant on NZSFC donations to conduct valuable research in the interests of recreational fishers.

# CAULERPA SPREAD DISCUSSIONS

In August 2023, there were three hui meetings held to address the spread of Caulerpa, an invasive seaweed, particularly along the northeast coast. Biosecurity NZ is still in the

process of determining an appropriate and financially feasible response plan. Key points of interest include:

- 1. Ngāti Manuhiri Roadshow Hui: These gatherings occurred in Bay of Islands, Auckland, and Whitianga on August 5th, 7th, and 9th, respectively.
- 2. Waiheke Rāhui Imposed: A rāhui was established on the north side of Waiheke Island, extending 1.0 nautical miles from the coastline, restricting activities such as anchoring, diving, and fishing.
- 3. Aotea Great Barrier Biomass Control Trial: A suction dredging trial to control Caulerpa biomass is scheduled to commence in early September.
- 4. Kawau Caulerpa Removal Trial: A trial for the removal of Caulerpa around Kawau Island was expected to begin on August 14th.
- 5. Controlled Area Notices: These notices prohibit diving, fishing, and anchoring in specific areas, including Aotea Great Barrier Island, Ahuahu Great Mercury Island, and Te Rāwhiti Inlet in the Bay of Islands.

NZSFC has taken a strong interest in this issue, and have been keeping the issue front and centre with the relevant Government agencies. This is a critical issue, as the invasive seaweed has the potential to affect both the ecosystem and also our access to the best boating and fishing locations. We will keep you posted on developments.

### YOUTH OCEAN TRUST DEVELOPMENTS

The YOT, named "Nga tai tamariki ki te moana," aims to secure funding for youth activities related to ethical fishing practices, water safety awareness, sustainable fishing, and marine conservation. The current YOT trustees are actively seeking additional members, and the trust is progressing towards finalising its budget based on its trust deed guidelines.

In recent meetings with the YMCA regarding the recent Surf Safety Camp Pilot programme, opportunities for NZSFC involvement through the Youth Ocean Trust have emerged. These pilot camps provided a valuable introduction to ocean-based activities for youth from Decile 1 and 2 backgrounds, including fishing. The feedback from participants has been overwhelmingly positive, emphasising the impact and demand for these camps.

Growth potential and shared responsibilities are on the horizon, as representatives from various organisations plan to explore avenues for expanding the Surf Safety Camps. These camps have not only proven successful as a proof of concept but also as a platform for grant-seeking to fund a wider rollout.

There is no expectation of financial contributions from NZSFC or YOT for the upcoming summer season of Surf Safety Camps and provides a possibility of one aspect of the Youth Programme going forward.

The Youth Programme is planned to enhance the engagement with youth, our clubs and the community through a wide range of activities - ultimately to grow awareness of Fishing and Clubs - and also the next generation of Club members, fishers and Committees.

## AOTEA GREAT BARRIER ISLAND CLOSURE

An application for a 2-year temporary closure under Section 186A was submitted to FNZ on August 21st by Motairehe Marae Trust. NZSFC, LegaSea and New Zealand Angling and Casting Association have opposed this after feedback from clubs. Concerns raised by Clubs adjacent to this requested closure include:

- 1. Denial of Public Access: The closure could deny public access to the area.
- 2. Impact on Fishing Effort: Without a plan to reduce catch limits, this closure may displace existing fishing efforts into other areas, affecting Hauraki Gulf, Coromandel, Bay of Plenty, and East Northland.
- 3. Lack of Depletion Address: The closure does not address depletion issues.
- 4. Possible Opposition: It is anticipated that other groups and commercial fishers may oppose this application, though no feedback has been received from FNZ yet.
